Procedure for Challenge of Answer Key (s)

1. Please go to website <https://exams.nta.ac.in/AHCRE/>.
2. Click on “**Display of OMR Answer Sheets, Recorded Responses and Provisional Answer Keys of Stage-II Examination held in 9th March 2025 for the post of Group-D under UP Civil Court Staff Centralized Recruitment: 2024-25**”.
3. Login with your **Application Number and Date of Birth** and enter Security Pin as displayed and submit.
4. Click on “**Click to View/Challenge Answer Key**”.
5. You will see a table of your personal details on top and another table below, with the columns, Question Number in sequential order, Correct Option(s), Option(s) ID claimed and Test Booklet Code.
6. The Answer Key given is the one to be used by NTA for preparing/finalizing the result.
7. If you wish to challenge this option, you may click on any one or more of the five check boxes against the desired option.
8. You may also upload supporting documents in which you can select ‘**Choose File**’ and upload (all supporting documents to be put in a single PDF file).
9. After clicking your desired option, scroll down, ‘**Submit and Review Claim**’ and move to next screen.
10. You will see a table of answer key options claimed by you.
11. You may review the options claimed by you and modify them if you so desire, by clicking on “**Modify Claims**”. Else you can click on “**Final Submit**” and move to next screen.
12. Click on ‘**Challenge Answer Key Pay Now**’.
13. Select “**Mode of Payment**” and pay processing fee @ **Rs. 500/-** online for each question challenged. Payment may be made through Internet Banking, Debit Card, Credit Card or UPI.
