They are further advised to make correction/s in their particulars, in their respective Application Form, if required, latest by **27th December, 2024 (up to 11:50 P.M.)**. Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through **Credit/Debit Card/Net Banking/UPI**.

Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.
