2.	What is CUET (UG) – 2024?	 CUET (UG) – 2024 stands for Common University Entrance Test (UG) - 2024. CUET (UG) – 2024 provides a single window opportunity for students to seek admission in any of the Central Universities (CUs), and other participating universities (State Universities, Autonomous Institutions, Private Universities, deemed Universities) across the country, for the academic session 2024-25. CUET (UG) – 2024 provides a common platform and equal opportunities to candidates across the country, especially those from rural and other remote areas, and helps establish better connections with the Universities.
