The key finalized by the Experts after the challenge will be final and no further communication will be entertained.

Procedure for Challenge of Answer Key(s)

- 1. Please go to https://exams.nta.ac.in/CUREC/
- 2. Go the Link "Click Here to Answer Key Challenge"
- 3. Login with your Email Id and Date of Birth and enter Security Pin as displayed and press the Login button.
- 4. Click on "Candidates Previous Answer" for viewing your marked responses
- 5. To View & Challenge the Answer keys, click on the link "Challenge".
- 6. You will see Question IDs & Correct Options in sequential order.
- 7. The column 'Correct Options' stands for the correct Answer Key to be used by NTA. The Dropped Questions are highlighted and not for challenge.
- 8. If you wish to challenge this option, you may use any one or more of the Option IDs given in the next four columns by clicking the check box.
- 9. After clicking your desired option, scroll down, upload supporting documents. For which you can select 'Choose File' and upload (all documents to be put in a single pdf file).
- 10. To save your challenge press the "Submit & Review Claims" button. A message on screen showing "Data Saved Successfully" shall pop up.
- 11. You will see a display of all the Question IDs you have challenged and a Button "Pay Now" to pay the fees.
- 12. Click on 'Pay Now' button & pay the required fees or in case you wish to modify the claims, click on 'Modify your Claims'.
- 13. After completing the process, you can see on your Challenges displayed on the screen.
