Online Applications are invited for the posts of Lower Divisional Clerk/Junior Secretariat Assistant and Section Supervisor in EPFO from the eligible officials of EPFO. Eligible officials are required to go through the EPFO Notice No A-34012/1/2022-EXAM/75 dated 11.06.2024 and EPFO Notice No A-34012/2/2022-EXAM/72 dated 07.06.2024 respectively.
