The National Testing Agency (NTA) is going to conduct National Teachers Eligibility Test (NTET) - 2025 for Postgraduates of Indian Systems Medicine and Homoeopathy who desire to take up teaching profession on 17th of July, 2025 in Computer-Based Test (CBT) Mode at different centres located in various cities throughout the country.

2. As per the information published in Information Bulletin and Public Notice, it has been decided to provide an opportunity to the candidates to make corrections in the particulars of their respective Application Forms of NTET - 2025 as per the following details:

Please note that final correction shall be applicable only after payment of an additional fee if required. In case of change in Category, or PwD/PwBD status, if there is an impact on the fee amount then the Candidate will be charged an excess fee as applicable. Excess payment made will not be refunded, if any.

3. All the registered candidates for the said Examination are advised to visit the website (<https://exams.nta.ac.in/NTET/>) and verify their particulars. They are further advised to make correction/s in their particulars, in their respective Application Form, if required.

4. The candidates are allowed to make the corrections, latest by 27 June 2025 (up to 11:50 P.M.). Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through Credit/Debit Card/Net Banking/UPI.

5. Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.
