They are further advised to make correction/s in their particulars, in their respective application form, if required.

The candidates are allowed to make the corrections, latest by **08 April 2024 (up to 05:00 P.M.).** Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances.

Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are advised to do the correction very carefully, as no further opportunity for correction will be given to the candidates.
