Procedure for Challenge of Answer Key

1. Please go to the website <https://exams.nta.ac.in/UKHC/>
2. Click 'Challenge Answer Key/ Challenge OMR Sheet'
3. Login with your **Application Number and Date of Birth**, enter the Security PIN as displayed and Submit.
4. Click 'Challenge (s) regarding Answer Key'
5. You will see the Question IDs in the sequential order.
6. The ID next to the question under the column '**Correct Option**' stands for the most appropriate Answer Key by NTA.
7. If you wish to challenge this option, you may use any one or more of the Option IDs given in the next four columns by clicking the check box
8. You may upload supporting documents for which you can select 'Choose File and Upload (**all documents to be put in a single PDF file**)'.
9. After clicking your desired option, scroll down and 'Submit and Review claims'.
10. You will see a display of all the **Option IDs** you have challenged.
11. Click on '**Final submit and Pay Fee finally**'.
12. Select the Mode of Payment and Pay a **non-refundable processing fee @ ₹ 200/-** for each question challenged. Make payment through Debit / Credit Card / Net Banking.
